Megan Butts gave a presentation to the Board via Zoom to give a brief overview of what UVLSRPC does and what benefits they can offer to Sunapee. The presentation is included in the minutes.

SELECTMEN ACTION

•Sign 2020 Second Half Tax Warrant

Motion to approve and sign the 2020 Second Half Tax Warrant by Selectman Gallup seconded by Selectman Gottling. Unanimous.

•Special Detail Fund Expense \$1,176.70

Chief Cahill submitted receipts for lithium batteries, safety vests, rechargeable flashlights, belts, and boots totaling \$1,176.70 that would be expend from the Special Detail Fund. Motion to approve the expenditure of \$1,176.70 from the Special Detail Fund by Selectman Gottling, seconded by Chairman Trow. Unanimous.

•EMPG-S (Emergency Management Performance Grant) Grant Program Donna Nashawaty said there was a COVID grant that got turned into a Homeland Security and Emergency Management Grant for Emergency Operation Centers. Donna Nashawaty wanted to compliment and credit Steve Marshall who asked for a few radios and then it turned into the EOC Portable Radios project. The project cost is 50% or \$17,994 Town share, which is coming from GOPHER funds and 50% grant (Federal Funds) for a total cost of \$35,988. The process is as follows, the Board of Selectmen would accept the terms of the grant agreement with the sample language that was given with the instructions, the executed grant agreement will be forwarded to the Department of Safety for the review process. The radios will need to be purchased and then the Town will received a reimbursement check after receiving appropriate backup documentation. Motion that the Select Board, in a majority vote, accepted the terms of the Emergency Management Performance Grant as presented in the amount of \$17,994.00 to purchase portable radios for the community's Emergency Operations Center (EOC). Furthermore, the Board acknowledges that the total cost of this project will be \$35,988.00, in which the town will be responsible for a 50% match (\$17,994.00) and authorize Chairman Trow to sign all documents related to this grant by Selectman Gottling, seconded by Selectman Gallup. Unanimous.

CHAIRMAN'S REPORT

- •Chairman Trow said that one of the items that has been expanded on by the State is that the Selectmen are required to provide a plan for a secondary voting location. Since the election is tomorrow, there will not be any action tonight, but it should be discussed and drafted so there is an official written policy before the next election. Items Selectman Augustine requested:
- •Update on COVID-19 cases in Sunapee and nearby towns Selectman Augustine gave an update on the COVID cases that have been reported by WMUR.
- •Update on Sunapee Harbor boat launch project Selectman Augustine had asked for an update on the Harbor Boat Launch. Chairman Trow replied that the boat launch is closed. There was about a week delay in starting due to contractor scheduling issues, that have been resolved. The project will take six weeks.
- •Sunapee's tax payment to Sullivan County 2020 versus 2019
 Selectman Augustine said according to the tax rate setting sheet that was emailed to the Board, it looks like the payment to the County will be lower this year than the previous year, do we know why? Donna Nashawaty replied that the Sullivan County budget was level-funded and the apportionment that is calculated every year is calculated on every town in the county and their assessed value.
- •Cost of living pay adjustment (COLA) to be used in 2021 Town budget proposal Selectman Augustine was curious what the COLA amount was in the 2021 Town Budget. Donna Nashawaty replied the COLA percentage used would be 1.2%.

TOWN MANAGER REPORTS

Donna Nashawaty said the 2021 budget is on the website and the Committee Budget Book will be available tomorrow afternoon.



Providing Acceptance of Grants Documentation

Hi Olivia and Whitney,

According to NHDOJ, if communities have the electronic means, they are allowed to meet remotely to conduct their meetings with the public joining in remotely. This setup should be stated in their minutes.

If the community is not set up for meeting remotely, they can post the grant information in advance on their homepage and invite comment from the public via phone calls, emails, etc. Then as long as the grant is approved in a Board meeting that complies with the emergency orders (12 and 23), that will be accepted. Again, in the town's meeting minutes they should state this means of informing the public. The invitation for public input is very important.

As for documentation, they can still provide the minutes from the meeting showing grant approval as they usually do and they can state in their minutes how the public was notified, whether it was via remote meeting, posting of grant information with invitation to respond, etc.
