SCC has a commitment of approximately \$31,000 by year end for the Blackington & Collins Project. (Note the Stewardship fee of this project may be broken out into payments and spread over a 5 year time frame for budgeting purposes)

Andy Deegan with ASLPT reported that the ASLPT Board has approved and accepted the Nutting Property Project. There are no budget numbers available yet for the purchase of the Conservation Easement. The Project may need fundraising and/or a warrant article to close. The Conservation Easement will be standard wording. ASPLT will schedule and pay for the Appraisal and the survey of the Nutting Parcel. SCC will reimburse for those two expenses.
