## 10 NEW CASE

11 CASE 22-07 PARCEL ID: 0118-0056-0000 SEEKING A VARIANCE FROM ARTICLE III, SECTION 40(J) TO

12 CONSTRUCT A DETACHED (2) CAR GARAGE (28X28) WITH A RETAINING WALL OUTSIDE THE BUILDING

13 SETBACK LINE AND HIGHER THAN 42". 70 BURMA ROAD; PAUL & SHEILA LEWIS.

- 14 Chairman Claus notified the applicants that there are four out of five members present and that they
- 15 would need three votes to get their Variance approved and asked them if they want to continue. The
- 16 applicants agreed to proceed further.
- Thomas Dombroski started presenting the case by reading through the five criteria from theirapplication.

19 Chairman Claus noted that the applicants are asking for more than one Variance, according to their 20 application.

- 21 Mr. Dombroski confirmed that there are three variances that they are asking for in their application.
- 22 Chairman Claus explained them that they should present each Variance through a separate
- 23 case/application and that the Board could only vote for one Variance at this meeting. The Board later
- established that there are actually two Variances needed about this case, excluding the erosion control
- 25 plan variance.
- 26 The Board gave the applicants the option to withdraw their case now and come back for the next
- 27 meeting to present both cases/variances in separate applications. The applicants were also reminded
- 28 that they need to fulfill all of the five criteria presented in their case, emphasizing the unnecessary
- 29 hardship criteria presented in this particular case. They also suggested that the applicants may need to
- 30 consult more experts on this matter such landscape architects, engineers, lawyers, to get some more
- advice through the Town and consult the Zoning Administrator about their case.
- 32 After further discussion with the Board, the applicants have decided to withdraw their case and reapply
- but asked if there is any way they could be put on the agenda for the next meeting. The Town Manager
- told them that she will talk to the lawyers the next day about the options and give them update on this
- 35 matter.

- 36 Chairman Claus advised the applicants that if they have come to him and asked, he would probably have
- told them that they would have a really hard time getting the Variance, based on the hardship criteria
- 38 and that they should try looking at other options, to possibly avoid a variance.
- 39 MISCELLANEOUS: Review Minutes from Previous Meeting(s). Postponed for the next meetings.
- 40 OTHER BUSINESS: Chairman Claus addressed the email that he had sent to the members about the
- 41 Planning Board that is going to start the public hearings for making any amendments for the Ordinance
- 42 and if they have any suggestions for that.
- 43 The Board had some discussion about various hypothetical zoning cases.
- Daniel Cave had expressed concerns about the ability to join the meetings through Zoom and the link tojoin in.
- 46 Chairman Claus made a motion to adjourn the meeting at 8:25PM. Mr. Lyons seconded the motion.
